All pieces must be reported on the appropriate line at the full published price (not including the Full-Service Intelligent Mail incentive). Pieces that comply with the Full-Service Intelligent Mail option requirements are additionally reported on the line provided. The following information will help you to determine which parts to complete:

Parts A-C: Letters

- Part A: Automation Letters. Enter total in Part A Total box.
- Part B: Nonautomation Letters. Enter total in Part B Total box.
- Part C: Carrier Route Letters. Enter total in Part C Total box.
